The meeting of the cell was organized on 12/01/2022, in the Principal's office. Following members of the Anti-ragging cell were present during the meeting.

The meeting of the cell begins with the welcoming of all the members by the convener Dr. Sudesh Bhorate. Dr. Bhorate invited Principal Sir to chair the meeting.

With the permission of chair the first agenda of meeting was opened. It was confirming the minutes of the previous meeting. First agenda of previous meeting was to prepare a plan for the session. The first plan was class to class campaign with notice and second plan was to visit different places in the campus as an Anti-ragging squad. Both

plan were implemented by the members. Also during the Anti-ragging squad visit no such incidents of harassment were observed. Teachers interacted with junior and senior students both, and they seemed quite secure in the campus. Principal Dr. Patil supported the reporting with the thought that there have never been such incidences reported in the campus before.

The third agenda of previous meeting was to take a review of the Rule boards and sign boards. members had visited the different places and recommended to replace a few boards. In the following week some new boards were put up in the places.

The next agenda of previous meeting was to induct two students. Both the students included in the vigilance squad and invited for the meeting.

Since all the agenda of previous meeting found implemented with the permission of chair considered as all confirmed.

Coming to the current agenda of the meeting, the second agenda of meeting was to review the activities of the cell. Mr. Bharrate, narrated both the activities of classroom to classroom campaigns and Anti-ragging vigilance squad visits to different places in the campus every week. Many a times Vice-Principal or Hararecha Bagade also joins the squad. No such incidences of harassment found during the visit. Also during interaction with the students no report of such harassment were heard by them in the campus.

The third agenda was to listen to the report of students, Mr. Lingaraj Salunkar from B.A. Eng. Med. and he continue to interact B.A first year students from all three mediums. and according to him, he found no such incidences occur in the college. Mr. Anup Gaur from B.Com first year he also supported Mr. Salunkar with his opinion that no such incidences were reported from commerce faculties.

The last agenda was to discuss the issues raised with the permission of chair, but no new issue was taken up by any. On the occasion principal Dr. Veshant Patil appreciated both the students for their cooperation for the Anti-ragging cell during the session.

The meeting was concluded with vote of Thanks proposed by Mr. Megha Rautels. The meeting was ended with the tea offered by Mon. Principal Sir.
